**Franklin High School
Dance Contract 2017**

This is an agreement between the student(s), the parent(s), and the administration of Franklin High School. By signing this agreement, you, your parents, and the Principal/Superintendent have an understanding of what is allowed, and what isn't allowed at our school dances. You have also indicated your intent to abide by these following expectations at FHS dances.

Dance Policies:

- All students must sign and submit the dance contract in order to attend a school dance.
- Students must have a valid FHS ID and/or ticket to enter the dance.
- Once a student leaves the dance they may not return without identification and/or a wristband provided by ASB.
- School and District policies will apply at all times to all high school related activities.
- If a student is suspected or determined to be under the influence of or in possession of drugs, drug paraphernalia, or alcohol, then parent and administration contact will be made.

Expected Student Behaviors:

- The manner of dancing will be appropriate for a school function. Sexually explicit dancing will not be tolerated. Sexually explicit dancing is defined as the following:
 - Students are not permitted to bend over
 - “Freaking”, or any mimicking of sexual acts is not permitted.
 - there must be space to allow chaperones to easily move about the dance floor.
 - No “making out” and/or prolonged public displays of affection.
- This contract is considered the one and only warning for dancing inappropriately. Students who are dancing inappropriately will be removed for the dance. Once a student leaves the dance, the school is not responsible for the student or her/his actions.
- If a student is asked to leave the dance, a parent/guardian will be notified and no compensation for any costs of the dance will be refunded.

Dress Code:

- Students are to dress appropriately.
- All Clothing must remain intact in its proper place throughout the dance.
- Any outfits that expose excessive amounts of skin, including the midriff, chest, or legs are not appropriate.

Implied consent:

By reading this document I agree to accept the above standards for my behavior and fully accept responsibility for my actions and the consequences imposed. I understand that failure to comply with any of the dance expectations will result in removal from the dance/activity without a refund.
